Clothesline Fresh Detergent EP is a highly concentrated formulation allowing for superior cleaning even when diluted down to 1:512 (1/4 oz./gal.). This product is safe to use in high efficiency machines.

- Sort laundry by color and fabric type.
- Always read and follow care directions.
- From care directions, choose proper wash cycle and water temperature.
- Do not overload washer with soiled laundry.
- Add Clothesline Fresh Detergent EP
  - Top load washers: Use 1/8 to 1/2 cup (1 to 4 oz.) depending on soil load.
  - Front load washers: Use 1/8 to 1/4 cup (1 to 2 oz.) depending on soil load.
- For extremely soiled laundry, an extra wash cycle may be necessary.
